We implemented a monthly newsletter to our 1,800 members and strategic partners with a video message from me and written updates from our key leaders. Intergovernmental collaboration and partnerships were part of my role in this position. I was invited to the White House by two sitting Presidents.

# Hancock County Veterans Service Office (OH), 2011-Current

Since being hired to serve as the CVSO and executive director for the office in 2011, I have grown the team from two part-time and one full-time person to six full-time, eight parttime, and four active volunteers. With this purpose-driven team, we serve more than eight times the number of veterans and family members served in 2010 or earlier. Additionally, the VA benefits received by our militaryconnected residents have increased by more than \$16.8 million. In this position, I have been responsible for developing and implementing policies and processes to ensure our team accomplishes the mission outlined in state law. I directly supervise the five executive members of our team and work closely with the local elected officials.
